- I. A motion to approve the minutes of the February 10, 2016 Regular Meeting was made by Dan Dubbs and seconded by Ruthann Meyer; Steve Nathan abstained; all in favor.
- II. Treasurer's Report Kirsten Canuso presented the Treasurer's Report through March 9, 2016. A discussion ensued about planning for a new boat for next fiscal year and looking at the launches and motors to see if any need replacing. These are major expenses. Perhaps we should try to get a new launch every year. Stephen Martinelli suggested that we get rid of some items also. A motion to approve the Treasurer's Report was made by Stephen Martinelli, seconded by Dan Dubbs; all in favor.

- IV. Committee Reports
 - A. Fundraising Ruthann Meyer stated that she has had many volunteers for Bingo the goal is to raise \$9,000.00. May 15th Clean communities two spots \$500.00 each. April 16th is car wash. Yard sale will be some time after crew season is over. Bagging at Shop Rite will happen again.

- D. Boys Liaison Jane Mack reported that she still has uniforms to give out and she also needs to collect 16 dinner club packets that were not handed in at the stroke dinner along with handing out a few 50/50 packets.
- E. Boat House Cape May County Freeholders had a meeting to sign the application last night. Stephen Martinelli will be meeting with two Upper Township Committeemen and the Zoning Officer about the application. The application will cost about \$6,000.00 for the NJDEP application fees and \$1,500.00 for Mike Lucey. As soon as the County gives us the application I will contact Kirsten Canuso for the checks. The County has requested that we refer all inquiries from the media/press to Dianne Wieland at the Cape May County Publicity Office.

- G. Food Tent Thank goodness Mary Jean Majka is back on her feet after her accident. The only thing we don't know about is the propane. The trailer will be at the boathouse this week so the food will be delivered there. It is a 2" trailer ball. Chris Meyer will bring the trailer back to the erg room where the trailer will stay from now on. Stephen Martinelli said that we spoke of storing non-perishable items off-site. These items will not be at the erg room he may take the trailer to his house and clean it, re-stock it and return it to the erg room. There is an extra grill and a lot of old items such as tubular tents can they be relocated to the yard sale storage facility? Steve Nathan made a motion to allow Stephen Martinelli to clean out as he sees fit seconded by Dan Dubbs, all in favor.

V. Old Business

- A. Yearly Budget Stephen Martinelli said we need a formal yearly budget
- B. Safety on the Water Walkie talkies with flashlights for all launches. Karen Koptic said that her husband picked up two radios at West Marine Chris Storcella and Chris Meyer should compare. Steve Nathan said why should we buy flashlights if they do not use them. Ruthann Meyer said they should not be on the water without the safety equipment. Jennifer Cooper agreed with Ruthann Meyer. Ruthann Meyer suggested a "board order" to the coaches be sent expressing the urgency of having the safety equipment in the launch. Steve Nathan said that the directive has to come to the Athletic Director of Ocean City High School. Stephen Martinelli reminded the Board that we had this discussion last year and the coaches stated that they use the safety equipment. The coaches need to know we are watching. Ruthann Meyer said we have to be consistent.

C. Summer Crew Camp & Experienced Rowers Camp (Masters Sponsored) – Suze DiPietro stated that she is already getting emails and calls about summer camp – the sooner we get it on the website the better - without the city again - last year it was \$150 each; we had 60 rowers – 45 rowers the year before and there was a lot of out-of-town participants: Ruthann Meyer suggested \$200.00 – Stephen Martinelli said his daughter went to a coxswain camp at Cornell and it was \$135 for one day; Kirsten Canuso said that we have many expenses to think about; Steve Nathan said perhaps \$175.00 – Suze DiPietro said she feels we will price ourselves out. Mary Jean Majka asked if we can sign kids up at the Middle School – yes was the answer. How many rowers can we take? Did everyone go out and row – can the coaches handle them – these are questions we must consider. Dan Dubbs asked about what other clubs charge. Jennifer Cooper said Brigantine has at least 6 coaches with 2-3 kids assisting and they rotate – ergs, water and dry land. The students volunteer their own time. Kirsten Canuso said Viking does it too. Dan Dubbs said if we are charging \$200 and Brigantine is charging \$100 they are going to Brigantine. Steve Nathan said we need to have a better coach-rower ratio. We had trouble finding coach volunteers. Jennifer Cooper said Brigantine, Viking and Lenape have multiple camps with different times of the day. Steve Nathan said we did not have it organized well enough. Kirsten Canuso said we also need to decide what we should pay the coaches. Suze DiPietro said we need a meeting just for summer camp – March 22, 2016; 7:00 pm to discuss only summer camp. Stephen Martinelli asked if the coaches should come - Suze DiPietro said she will contact the coaches.

Last year, the Masters rowing program was in the morning. Suze DiPietro will be completing the 501(c) paperwork and purchasing liability insurance for the Masters. She stated that they thought that sessions should be 4 weeks of 5 day camps. Two prices – OC rowers get a discounted fee. The coaches being used this year Alex Grossi, Zach Eberson and John Chester. Suze DPietro will put together a plan and schedule and bring it to the next meeting. This camp will be in the morning and not interfere with the other. Stephen Martinelli said you may want to mention this camp at the meeting also. Steve Nathan agreed. The Masters program will be different this year – you can be recreational or competition racer – it was hard for the women to commit after school year begins. Suze DiPietro would like to charge \$250.00; \$50 to scholarship fund and \$200.00 to OC Crew Boosters. A website will be made with a link to OC Crew boosters. The past two years we have learned a lot and we are looking forward to this year's summer program. Steve Nathan suggested that you plan ahead for the next couple years so that you can purchase your own quad boat in the future.

- D. Mail drop box inside erg room Karen Koptic said that at the stroke dinner, some people forgot monies and/or tickets so perhaps maybe we could have a mailbox (\$18-\$50) inside the erg room or the trailer. Kirsten Canuso said that her children collect monies/tickets and bring home to her.
- E. Preparation for this week's race still need volunteer to take trailer from Philadelphia Steve Nathan volunteered.

- G. CrewZaPalooza Saturday, April 16th Suze DiPietro stated that they will need help setting up. In addition, she asked if the Board wanted the band to play again yes was the answer.

There will be a boathouse committee meeting, Monday 3/14/16 at Suze DiPietro's house at 7:00 pm.

Ruthann Meyer stated that at the first stroke dinner there was a family that stated that they did not have to sell and tickets because they sold a \$300.00 spot on the banner. Ruthann Meyer reiterated that there will be no exceptions – we all have to sell tickets and pay the food tent fee and bond. Steve Nathan said last year we had an exception, which was voted on and approved by the Board, that a name would appear on the banner in lieu of charging for winter boat storage. Ruthann Meyer also said she had a lady say no I am not selling them. Every time they decline it is \$500.00 – especially since we give discounts to the multiple rower families – we need to really address this. Ruthann Meyer requested permission to post a note thanking the parents for selling their tickets. Karen Koptic will ask the Athletic Director if we have any options.
