## XI. New Business

- E. Summer Camp Mario Japzon talked to Coach Millar he wants to head it again and put out a flier and start advertising now we charged \$175.00 last year, we will be charging \$200.00 this year. Mario Japzon asked if someone would take over the advertising, he will create a flier.
  - 1. Dates same as last year last two weeks of July, first two weeks of August with the regatta last August 14<sup>th</sup> & 15<sup>th</sup> (raindate)
  - 2. Advertising budget \$500 for ads

Dan Dubbs made a motion to spend up to \$500.00 for advertising summer camp, seconded by Mario Japzon – vote taken – unanimously approved.

F. Coaches – Rocco is helping the girls team because Kait is not available every day. Coaches would give stipend to assistants. Dan Dubbs said would create a bad precedent.

Chris Meyer -9.9 Yamaha \$2,045.00; wait until fall and see if we can get a better deal, we should be able to get through the season.

Allison Yoa had a question – have coaches ever submitted guidelines as to their behavior and consequences of their actions – accountability. There was some kind of contract that they signed – I have not seen it. Dan Dubbs and David Krause said it is like a code of conduct. Mario Japzon said he received a lot of complaints from the parents - he has not discussed this with the coaches – it is a fine line, especially since they are paid through the school. Allison Yoa feels that they have a moral obligation that they are here for the kids and it is a slap in the face to treat them unfairly. Dan Dubbs said in-season, the coaches are paid by the school; it is not just happening in our sport. Allison Yoa said they need to stop threatening them if they are not going to follow through. Mario Japzon said our hands are tied – we have no control over the coaches during this time.

Donna Oves said it is the same with collecting the fees – the coaches allow them to row whether aid

Mary Jean Majka stated that boat should never win and then listen to the coach tell them they didn't look good – the negative comments from the coach after winning a race are unacceptable. Also, I think we need to address that if someone quits, they should not be allowed to come back, it wasn't as though they were sick – it has directly affected my daughter.

Agenda for the parent meeting was discussed.
