Coach Millar would like to get permission from the Board to advertise on Row2K. Coach Millar said that he knows it is the girls turn for a new boat, but we can sell boats to help both. Would like to sell the terminator (lightweight 8). Coach Tapp would like to sell two sets of oars and purchase two new sets of oars. New oars cost \$8,500.00 for two sets; sell set of 10 for \$2,000.00. Tapp said we have some boats that are just sitting there-he can sell them to Alex Delsordo at Finish Line if he would purchase all in one deal and he can resell to other start up clubs. Marist has a boat for sale – red - only used on freshwater for \$10,000.00 – I have at least 6 8's for next year. Dan Dubbs stated we can lease a boat also.

Coach Millar spoke with new AD and he seems to be open with ergs in the cafeteria. Mainland is willing to race again this fall against girls and boys this year. When we go to Mainland in the spring it will include the girls also.

The boat selling/purchasing was tabled to the next meeting and a list of boats along with their condition will be emailed to all Board members by Mario Japzon.
